This adoption fee is used to cover the costs of making dogs available for adoption which includes but is not limited to:

\$85 Spay/Neuter fee, \$15 microchip fee, \$10 Rabies Vaccine, \$10 DHL-PP Vaccine, \$10 Bordatella Vaccine.
