INFORMATION, CORRESPONDENCE, DISCUSSION:

Fire and Emergency

- Sharon approached the board about a 911 call made on 12/2/14. Cincinnatus never responded. It took 40 minutes for Marathon to get there. The man passed away.
- Suggested that all the towns that are paying for coverage get together and demand to know where their money is being spent
- Steve contacted Penny to come to meeting tonight to hopefully clarify some things but she called last minute and had to cancel due to other plans
- She stated that they have meetings the 3rd Tuesday of the month and anyone from Taylor can go to their meetings
- Talk of possibly changing to private coverage but it may be too hard of a process without much need for it
- Believe it is public knowledge how many calls Cincinnatus receives and how many calls they actually respond to. Would like to know those numbers
- Would like to know what % of our contract money goes to Emergency Squad and what % goes to Fire Protection?
- As of the last meeting that Steve and Riley attended there they still did not have their budget completed
- Would like to know what the people volunteering there are actually qualified to do?
- There are all the surrounding towns paying all this money annually and not receiving very good service
- Would be ok with paying more annually if they could produce the services that we are paying for
- Decided that a group of people from Taylor need to appear at a meeting there and express their concerns

New Insurance Co-Op

- The numbers are not much different. Need to look into how much premiums with change
- Discussion about having someone come to a board meeting and talk more to the board about it
- Decided that it was no cost to look into it

McGraw Ash for Trash

- McGraw sent a letter asking for support with them again the Ash for Trash
- All board members agreed they were all for it, much cleaner than a landfill
- This might make the dump cost less and help increase recycling

Tax Assessor

- Do not need to have a new one hired until February 2015
- Steve going to be attending a meeting in Homer with other towns looking for assessor as well
- An advertisement was put in The Association of Towns magazine
- Other towns are thinking about one assessor for all of Cortland County

Fire Contract

- No choice right now but to accept it.
- We could send check without the increase and also look into TLC for amounts
- May be able to get other towns to go with TLC and get the cost down a little
- All other towns contract price went up except Cincinnatus
