Information, Correspondence, Discussion, Action Items:

Harassment Policy, Procurement Policy, Personnel Policies, Rules and Regulations, Drug Free Workplace Policy, Excessive Force Resolution Policy and Fair Housing Policy were presented and no one had any questions about them.

Fire Protection Discussion

Steve recently spoke with Sandy Doty of Willet about their fire protection contract. Willet rescinded theirs after they realized that it stated that the towns would be responsible for paying some of the insurance on the fire engines. Steve spoke to fire commissioner, Penny Eccleston and she gave Steve back ours to look over and Taylor's contract is actually different then Willet's. Steve faxed a copy to the town attorney to double check it. Steve noted that all the supervisors are complaining about the same things when it comes to Cincinnatus Fire Department. They felt all the town supervisors should get together and discuss what can be done. A round table discussion was held at the Cincinnatus Town Hall as per Cincinnatus Supervisor, Luann King's request. Riley and Steve attended this meeting. All of Cincinnatus' Town Board and area supervisors were present. Next Tuesday, January 18 is the next Fire Commissioner's meeting. Steve and Riley would like it if all our board members attended to voice their opinions. Still unsure of the time of the meeting. Riley spoke about the research he has been doing about Fire Protection Districts and he has found that at any time we are allowed to break our contract with Cincinnatus. He suggested that for this year we only pay Cincinnatus quarterly in case we are able to find something better. We may be able to get a contract with Willet, Marathon, Cortlandville, etc... anything with a better response time than Cincinnatus currently has. During the recent fire at Riley's garage; South Otselic and McGraw were able to make it to Taylor faster than Cincinnatus. Cincinnatus firemen showed up without a fire truck. No one went to the station first to get a truck. All the men were suited up waiting for a firetruck to arrive just watching the fire burn. 2 firemen stated where they came from and that meant that they drove straight through Cincinnatus and didn't stop to get a firetruck. They are both qualified to drive it but afraid to do so. It was stated that as the Taylor Town Board we have a responsibility to the tax payers to get them the best fire protection we can. We need to look out for our neighbors. It may come to where they need to look into having a full time driver for fire or ambulance protection. Cincinnatus Fire Chief is not happy with Willet so Cincy is not using Willet as their back up anymore, it is now McGraw. Question if Cincinnatus Fire Department is really looking out for the Town of Taylor? For the amount of money Taylor pays for fire protection, something needs to be done. If we rescind our prior approval until we get some answers are we still covered? Steve was told that if 911 are called somebody has to show up to the call. It is a mutual aid agreement. 911 will dispatch the next department.

Roy received a letter from the State about a shared service agreement. Jaymie read the letter aloud. It was summed up as an agreement with New York State that if there is an emergency we can go to them for help. They can bring equipment over to help up to \$10,000 worth of work. It goes both ways. The town would do the same thing if they asked for help. No money is exchanged. We can count of them for \$10,000 worth of free labor or equipment. The state is responsible for all their men and the town is responsible for ours. Do not need special insurance. This is just for emergency town work, not on state roads. For this to occur a shared service agreement is used to set up the arrangement for a one year term. Board signed the agreement.
