### Information, Correspondence, Discussion, Action Items:

Stadium International: Phil Brigandi

- \*Phi presented to the Board on pricing for ordering a new truck for the Highway Department from Stadium International.
- \*Pricing for a truck with a plow and a wing. Proposal of financing through First Niagara.

Board/Towns always used to bond for \$. Bonding can be locked into an interest rate for 2 years and then the next 3 years it could go up.

- \*For a municipality financing is a locked in rate for 5 or 7 years and will not go up. 5 years at 2.68% with an annual payment of \$39,819.96 or 7 years at 2.84% with an annual payment of \$29,362.04. No prepayment penalty.
- \*This is not a lease program; it's a finance program and own the truck.
- \*If ordered today it will take roughly 5 months to get the truck. 90 days to make out of the factory with another 2 months for the equipment to be installed.
- \*There really is no competition, they are all within \$1,000 of each other.
- \*Roughly \$10,000 more for automatic transmission instead of manual.
- \*Comes with computer software support for no charge, will come right to the town barn.
- \*Object of Overdrive transmission for climbing hills to get another gear out of it or driving flat roads and hauling all day, it gives a little more power.
- \*Suspension is Walking Beam, and no shocks on plow trucks
- \*Some customers over load trucks, and some beams do break. We do drive rough roads.
- \*Suggested to buy extended warranty.
- \*Single frame but could be built double frame.
- \*Do not cut a hole in the radiator for the PTO.
- \*Stainless steel box approximately \$7-9,000 more. Towns are keeping the box and getting a new truck.
- \*If decide to go stainless, pay attention to thickness of the steel.
- \*4-6 MPG on town trucks.
- \*Warranty comes as a 2 year on engine but can buy extended. Have 90 days after delivery to purchase a warranty for roughly \$4,000. After 90 days the price becomes prorated. Right now it may be able to be thrown in with the price of the truck.
- \*Emissions warranty is 5 years after the turbo, before turbo it is 2 years.
- \*Will do pricing on warranties and get pricing on stainless.

After Phil left the discussion continued.....

It was stated that Tompkins Trust is working on getting some numbers and amounts together. It was suggested by the Board for Roy to get some quotes from other companies. Get figures from Western Star. Russell stated that he personally would go with a Detroit over the International. We put roughly 10-15,000 miles per year so do we really need overdrive transmission? Roy stated that we can change any of the quote at any time. We are ok in the budget for making payments but need to look into the price of insurance and maintenance on an annual basis. There should only be minor repairs for first 5 years so \$4,000 for a warranty is worth it. Need to find out different grades of stainless.

Steve brought up to the board that he would like to purchase a new computer for the supervisor's office and give his laptop to the highway superintendent.
