- John Delvecchio held a Solar Law adoption discussion with the board members. There are currently no zoning laws in Taylor so this law would apply to all properties in the town. He suggested to incorporate a provision saying that any property that is considered prime farm land the town Planning Board can deny any application for a solar farm. Talked about the setback requirement of 100 feet from any property line, could go more, such as, 200 feet from any boundary line or 100 feet from any permanent residence, whichever is greater. The Planning Board can impose additional restrictions if they feel there are environmental issues are a factor. The town can adopt a pilot payment program and the town can also set their own building permit fees.

- Mitch told the board that the driver diversion program started officially today. County budget is not
  finalized yet. Looking at roughly 1.5 million. Mitch was told the livestock law should be over with. He
  also spoke to County Highway Superintendent, Charlie Sudbrink again about the stripe the county was
  supposed to paint on Whitney Road for them using it as a detour for so long.
