#### **DISCUSSION:**

• Pitcher Salt: Brad Hotaling, Pitcher Highway Superintendent showed Jeff the end of last year's numbers that he has. He explained that he weighs any new trucks he gets and with the load he figures it holds 4 ton. They had to go to Willet one time to get salt when we were out. Pitcher believes we have 56.5 tons of their salt. Jeff Blanchard, Pitcher Supervisor has no problem signing a shared services contract. Jeff Smith will get one from Sprague Insurance. Jeff Smith would like to allow them to continue storing their salt here until Pitcher can get a grant to build their own storage. Chris said he has 500 ton of salt he can order this year. Sand is coming as soon as Lincklaean is done getting theirs. All agreed that Pitcher can get their salt here as long as they only come when someone from Taylor is present.

- Town Line Bridge: Larry Hill sent his scope of work. Jeff called the DEC and talked to the biologist involved and is waiting for her plan. Once they receive Larry's plan they will let us know if we need a permit or not. Work should be completed as soon as we get the ok from DEC. Town of Cincinnatus is going to do signage and trees since they receive the CHIPS money for the road. Chris and Jim Latta, Cincinnatus Highway Superintendent will work to block it off.
- Monroe Tractor: Jeff received a phone call wondering why they have not been paid yet from the loader accident. We did get a check but it didn't cover all of the damage. Bryce was going to see about getting more money since the initial estimate was incorrect from Monroe. Jeff will ask Sprague when he meets with them.
- Stanley Access Technologies wants to sell a service contract on the Town Hall automatic door for \$446.70 for one year. All agreed no.
- VOLVO service contract will expire. This watches the truck and lets us know of a problem ahead of time. It came with a free two years. To renew is \$239 for one year and \$430 for two years, \$597 for three years and \$895 for five years. All agreed it was worth doing the five year with the savings.
