 - \circ $\;$ They will keep the information filed in their office and do not turn it over to our assessor
 - o Fran needs this information to her job
 - Their thinking behind it is this way we will have to hire them to do annual maintenance since they have our files
- Preference was that Briggs continue to do it since he has done ours before and he is familiar with the area

Sharon Eltz has volunteered to take over as Town Historian

HIGHWAY REPORT: by Roy Eltz

- Roy asked Debbie if she has received any checks back on CHIPS money and if she has completed his paperwork for him to be turned in
- Piece of equipment in the salt shed that cannot be used anymore, question on if he should sell it
- Board agreed that it should be sold since it is not used
- Question on if the town is looking for a grader. Used one for sale in Chenango Bridge to possibly look it
- New employee already has health insurance that does not cost him anything to have
 - Town has to offer insurance to him after 90 days of employment, but he is going to keep what he currently already has
- Question on if we pay for street lights per light or just a general amount
 - When the pole broke by the town barn and a the new pole was put back up it does not have a light one it
 - Stated that we just pay for street lights so the electric bill should go down, Debbie to keep an eye
 on the NYSEG bill
 - Stated that there should be a street light on that corner, should call and have it put back up

DOG REPORT

• One dog was picked up and then adopted out

BUILDING AND INSPECTION: by Michael Andersen

- Received a complaint on a mobile home in a field on Union Valley Road
 - Was told by the owner that he is going to tear it apart in the Spring
 - However, since he didn't get a permit to put it there to begin with Mike told him it was up to the board how long he can keep it there
 - He was supposed to have a certified hauler to move it there and a permit to put it on the property to begin with, he didn't do either

- Board decided to give him 30 days to have it gone
- Currently living in a camper in the town so the Health Department had to come speak to him about that too
- Received a complaint on Steve Fox's property about his many vehicles
 - Sent him a letter and gave him 45 days to have them removed. Enclosed a copy of the state law that says no more than 1 unlicensed/unregistered vehicle and no vehicle shall be in the state of disassemble
 - Major repairs and painting must be done inside a garage
 - Steve was not very happy about having to clean up but once a complaint has been made it has to be followed through on
 - Steve mentioned about putting up a tall fence but that will not matter because the cars are still there. If he had put the fence up in the past no one would have seen to the mess to complain
 - He can apply for a junkyard permit, but it will take some time to be approved or not. He would need to start with the county. There are a lot of rules and regulations to a junkyard
- At this time, they both have their deadlines to have it taken care of. If not taken care of it will then go to the Town Justice and with a daily fine set
- Brought up wanting to redo building fee amounts
 - Right now our fee schedule and building permits are very confusing
 - Also, small fee for everything. Still taking the time to go check the work so there should be a charge
- Lamb permit is still open
- Brooks Hill Road shed is almost completed
- Suarez Road roof is almost completed
- Talked to DEC-any outdoor boiler has to be 100 feet off the property line, must have an 18 foot stack, and must be a 2011 or newer boiler
- Stopped at Pittsley residence on Taylor Valley Road, have an email into the state about campers and how long people are allowed to live in them. They are not meeting the energy codes
