- Coal bin is still full at town garage, may end up needing more
- Discussion on getting rid of coal boiler all together at town hall
- There is still extra money in the NYSEG budget since we were budgeted for prior to switching to LED
- Highway Superintendent discussion
 - Carl Hoellerer and Justin Pittsley are both interested in the position
 - Justin worked for the Town of Solon for 3 ½ year and is currently working for the Town of Lincklaen
 - Carl has been working for Jeff and is currently still employed by the Town of Taylor

MOTION was made by Russell Eltz to nominate Carl Hoellerer as the Appointed Highway Superintendent for the Town of Taylor to fulfill Jeffrey Smith's term and was seconded by TJ Law.
