**Motion** to approve the August 2025 meeting minutes was made by Clint and seconded by Russell. All in favor, motion carried.

- Bond for Potter Hill bridge project.

FEMA to pay 75%, NYS to pay 12.5% and we pay 12.5% of the project cost.

Bond for 5 years for 1.2 million dollars.

Bond **resolution** was made by Jeff and seconded by TJ. All in favor, motion carried.

- Discussion of budget changes for 2026. A budget public hearing will be held in November prior to the regular monthly meeting.

- Discussion on reappointing Caitlyn Brown as assessor, she requested to the reappointment be done prior to October 1st.

**Motion** to reappoint Caitlyn Brown as Town Assessor for a 6 year term of October 1, 2025 to September 30, 2031 was made by Clint and seconded by TJ. All in favor, motion carried.

Building Report:

- There are currently permits open. A new build will be going in on Whitney Road. Will ask Tim about the new build off 26 by Union Valley Rd.

Planning Report:

- Amy Simpson & TJ Law subdivision on Doran Hill Rd.

Highway Report:

- The bridge project in Union Valley is underway.
- The county helped with Duke/Potter Hill Rd. grinding and Haines intersection.
- CHIPS letter for the amount of money to be received next year came and the amount should be about the same.
- Discussion about what can be charged for "in kind" work with CHIPS.
- Finished roadside mowing and mower was returned.
- On Hawley Woods there is a tree leaning way over, will call the county about it.
- Culvert pipe from bridge, Town of Pitcher would like to purchase it. Not sure if we have a place to use it here. Carl will check other culverts to see if we can use it, if not of any use, we can come up with a selling price.
- Shoe allowance not due until September 2026
- Going to hold off on getting rid of the 350 for now. Going to look into getting something smaller for parts running and checking roads. Going to revisit next month.
